Responding to Threats & Discrimination

Health care professionals who have been threatened due to providing health care services should:

- Follow the internal processes for your clinic or institution and notify the head of security, if applicable.
- Report the incident to your local [FBI field office](#).
- See the FBI [Threat and Intimidation Response Guide](#).

If you have been unlawfully restricted from providing health care on the basis of a patient’s gender identify, [file a complaint](#) with the Department of Health and Human Services’ Office of Civil Rights.

Tracking State LGBTQIA+ Policies

A growing number of states are considering or have passed laws that restrict or ban access to gender-affirming care. The American Civil Liberties Union and National Center for Transgender Equality track laws introduced in state legislatures affecting individuals who identify as LGBTQ.
